Terms and Conditions

(Please read carefully before completing registration form)

1. All grade 1 and Kindergarten students must have a valid annual bus pass, which will be issued by their school in September.
 2. The Alberta Government provides transportation funding for students who live 2.4 km and over from their school.
 3. No Provincial funding is available for students who live less than 2.4 km from their school.
 4. Routes are designed using the closest and safest pickup/drop off locations (such as, designated school bus zones, far side of crosswalks, or far side of intersections). **Bus transportation does not accommodate door-to-door service.**
 5. Parents will receive notification of their child's route information prior to the commencement of the school-year from their bus driver.
 - 6. Students should plan to arrive at their bus stop at least 5 minutes before the scheduled arrival time.**
 7. Please contact the Transportation Department if there are any changes to your information (such as, cancellation, change in address, or contact information). We can be reached by email at transportation@edu.lcsd150.ca or by phone at 780-826-3764.
 8. Registration does not automatically secure a seat for your child. Should buses in your area be at capacity, you will be contacted directly.
